## **Lehigh Valley Chapter Scholarship Guidelines**

- I. Name of the Scholarship  
The name of the scholarship sponsored by Lehigh Valley Chapter SCI shall be called "Lehigh Valley Chapter Scholarship".
- II. Purposes  
The purpose of this scholarship is as follows;
  1. To promote secondary education of Chapter members' children and grandchildren.
  2. To assist the qualified applicants with secondary education expenses.
  3. Award an annual scholarship of \$2,500.00 to one qualified student yearly.
- III. Committee Members
  1. This committee shall consist of no less than three(3) members of the Lehigh Valley Chapter SCI Board of Directors but no more than five (5)
  2. All information is strictly confidential.
  3. The committee shall review and decide on a recipient for the scholarship no later than December 31, for the following year the scholarship is to be awarded.
  4. All committee decisions are final.
- IV. Responsibilities
  1. Ensure the applicants are qualified as per the application instructions.
  2. Award the scholarship to the most qualified applicant.
  3. If a board members' child or grandchild is an applicant, and the said board member is on the committee, the board member shall relieve themselves of the duties of this committee.
  4. Require the scholarship recipient to sign a release for purpose of liability and publications.
  5. Distribute the funds at the annual fundraising banquet.
